Dear Sir,

With due regards, we wish to state that we are a manufacturer of thin flats (Patra) and has got a Re-Rolling Mill located at Mandi Gobindgarh. Our unit was commissioned in year 2007 and since then we were having a problem of higher power consumption as compared to the other local Re-Rolling mills. The cost per ton is becoming very high due to increase in the electricity tariffs in the state of Punjab. It was causing losses to our unit and becoming difficult for us to operate the mill due to competition from other mills.

We approached National Institute of secondary steel technology (NISST), Mandi Gobindgarh under Ministry of steel and have got done the energy audit of our Re-Rolling Mill located at Mandi Gobindgarh during Apr-June'13 and the report was submitted to us on 5th July'2013. With the recommendations and trials/modifications carried out during the energy audit, we were able to save around 30% savings in electrical energy consumption.

We are very grateful to you and also very thankful to the entire team of NISST, Mandi Gobindgarh for helping us to reduce our specific power consumption which is a National saving as well. It is requested to further strengthen NISST for covering more industrial units for the benefits of industry and our nation. Hope the services provided by NISST would continue to serve the industry especially SME's of steel sector.
