**MEMORANDUM OF ASSOCIATION
OF
NATIONAL INSTITUTE OF SECONDARY STEEL
TECHNOLOGY SOCIETY**

1. The Name of the Society is the National Institute of Secondary Steel Technology Society.
2. The Registered Office of the Society shall be located at SCO 27, Sector 26, Madhya Marg, Chandigarh.
3. Definitions; In this Memorandum, unless the context otherwise requires:
 - (a) "Act" Shall mean The Societies Registration Act, (Act No. XXI) 1860 together with its amendments made from time to time as also the Rules etc. framed there under.
 - (b) "Board" shall mean the Board of Governors of the Society.
 - (c) "Institute" shall mean the National Institute of Secondary Steel Technology (NISST).
 - (d) "Secondary Steel" shall mean steel or steel product(s) produced/manufactured by a process of making steel from scrap and/or Direct Reduced Iron (DRI) and/or Iron produced by any process other than Coke Oven and Blast Furnace process through and/or with the help of Electric Arc Furnace route and/or any other route and shaping it in the hot and/or cold rolling mill and/or through any other process.
 - (e) "Secondary Steel Industry" shall mean and include any person, firm or body corporate, whether governmental or otherwise, engaged in/or connected with the design, erection, manufacture processing, producing any/all plant, machinery etc. connected with secondary steel.
4. **OBJECTIVES:**
 - 4.1 To establish, maintain, run, manage and administer the Institute as defined in 3 (c) above and one or more other institute (s) as may be decided by the Board from time to time, in India and/or abroad.

- 4.2 To provide facilities at national and/or international level for imparting instructions, knowledge, experience, guidance, training, education, expertise and/or research in the field of steel technology including Secondary Steel technology and/or in areas/matters connected/ancillary/related thereto in any/all forms, content and manner including, but not limited to, in the form of full time courses, vacation courses, refresher courses, continuing education, distance learning and the like to all persons, firms and/or body corporates.
- 4.3 To provide facilities for training, educating and/or imparting knowledge, experience, expertise, guidance etc., to engineers, technicians, workers and/or such other persons in/related to steel industry including mini-steel industry.
- 4.4 To provide facilities in respect of training, guidance, education etc. to pupils, workers, technicians, officer's in particular skilled workers in the steel plants including in mini-steel plants and in particular in electric-arc furnace steel making units and rolling mills and in all allied and other areas in steel sector including in particular secondary steel sector.
- 4.5 To provide facilities for imparting instructions, education, knowledge, expertise, guidance, experience, training etc. in the disciplines of metallurgy, mechanical engineering, metal forming technology, fuel and thermal engineering, management, mathematics, statistics, operations research, production engineering, humanities, ergonomics, computer technology, space technology, deep sea technology and/or in any other discipline the provision of facilities whereof the Society deems fit.
- 4.6 To guide, assist, coordinate, provide and/or conduct research whether basic, applied or otherwise, in the field of any/all matters related to or, connected with steel sector, in particular in the secondary steel sector, including the field of electric arc furnace steel making and rolling.
- 4.7 To establish, commence, institute, continue, discontinue, award, impart, grant, etc. of any/all kinds and types of degrees, diplomas, certificates, fellowships, honours, scholarships, prizes, medals, grants, concessions, benefits, awards etc in respect of and/or connected with the objects hereof.

- 4.8 To seek, obtain, procure, and/or acquire from the Government whether Central, State or local, steel and/or any other industry and/or any other organization, institution, in particular educational and/or research organization, in India and/or abroad, recognition of the degree(s), diploma(s), certificate(s) and such other acknowledgement(s)/accreditation(s), etc. and/or to award, grant, or otherwise give/provide the said diplomas/certificates etc. to the pupils and/or others in respect of or connected with the activities/programmes/objects of the Institute/Society.
- 4.9 To provide, guide, sponsor, organise and/or assist in guiding, sponsoring, organising, providing, the facilities and services for, conducting/organizing seminars, workshops, talks, debates, conferences and such other activities, in India and/or abroad, in connection with and/or related to the objects hereof.
- 4.10 To establish, commence, manage, maintain, administer, organise and/or assist, guide, collaborate, in the establishment, management etc. of information, documentation and/or such other centre(s) for the institute or otherwise, in connection with and/or related to the objects hereof.
- 4.11 To call, invite, solicit experts, lectures, professors, speakers, administrators, Technologists, technocrats and any/all such other persons and/or dignitaries from and/or connected with the industry/other institutions, organisation, bodies, whether Governmental or otherwise, in India or abroad, and/or organise, conduct, guide, manage their lectures, courses, guidance, talks, seminars, workshops conferences etc.
- 4.12 To assist and/or acquire assistance from, collaborate and/or cooperate etc. with the educational, research, industrial and/or other institutions, societies, firms, organisations, clubs, bodies, whether governmental or otherwise, in India or abroad, having objects wholly or in part similar to those of the Society generally, and/or otherwise, as may be deemed conducive to the objects hereof, in any/all manner, and in particular by exchange of lecturers, experts, scholars, technicians, technologists, knowledge, technology, information, instructions, papers, documents etc.
- 4.13 To contact, discuss, negotiate, establish dialogue with, enter into agreements/arrangements with persons, firms or bodies corporate, engaged in, or connected with, production/manufacture of steel

including secondary steel, as also with designers, manufactures, suppliers, etc. in the field of steel making in respect of standardisation, manufacture, designing, erection, etc. of equipment and/or systems relating thereto, and/or with objects of improving, modernising, innovating, upgrading, introducing changes in steel technology and equipment as also in all other related matters.

- 4.14 To affiliate, collaborate, co-operate, enter into partnership, joint ventures, join membership and/or officers of/at/in/any/all other professional, honorary, technical or other membership/offices of/with any/all other institute, organisation, club, body, whether governmental or otherwise, in India or abroad, having objects wholly or in part similar to those of the Society.
- 4.15 To contact, negotiate, inter-act, establish dialogue with, enter into agreements/arrangements with, the industry, the steel industry generally, and in particular the secondary steel industry, in the areas of curriculum development, resources sharing, undertaking joint projects, education, training and guidance of pupil as well as the faculty and others, continuing and/or other education of industry personnel and/or the like.
- 4.16 To promote and encourage exchange of personnel, experts, technologists, technicians and/or other personnel, between the Institute and industry as also between the institute and other institutions, organisations, clubs, bodies, whether governmental or otherwise, in India or abroad, with a view to furthering and/or meeting the objects of the Society.
- 4.17 To contact, negotiate, establish dialogue with, co-ordinate, co-operate, inter-act with other institutions, organisations, clubs, bodies, whether governmental or otherwise, in India or abroad, for the purposes, inter alia, of curricula development, acquiring and/or imparting newer fields of knowledge, experience and expertise, upgradation of knowledge, ability and skill of all concerned persons including the institute staff, generally, and in particular through in service and external exchange programme.
- 4.18 To give, provide, impart in any/all manner, form and content, guidance, counseling, assistance, information, consultancy services to any/all persons, firms or bodies corporate, organisations, institutes, clubs, whether governmental or otherwise, in India and/or abroad, in connection with or related to the objects hereof, in particular in the

steel technology as also acquire, procure, accept, take such counselling, consultancy, etc. from such persons, bodies etc.

- 4.19 To keep track of and abreast with the newly emerging knowledges. Innovations, technologies, research work, in all fields of study and if and as and when deemed fit, incorporate the same in the educational and/or other curricula work, research, structural and other activities of the institute.
- 4.20 To contact, discuss, negotiate, establish linkage/arrangement with, the general educational sector, for the purposes of effective curricular adjustments, exchange of facilities, etc. for the benefit of the persons connected with the Institute, including the pupil.
- 4.21 To continuously update the curricula, teaching methods and learning resources and other connected matters and things to enable the Institute to maintain high standards.
- 4.22 To consult, coordinate, collaborate with the industry, particularly steel industry, laboratories, institutes, engineering and other colleges, research centres and such other organisations, whether governmental or otherwise in India/or abroad, for purposes of avoiding duplication of research efforts and/or utilisation of research facilities mutually.
- 4.23 To promote, encourage, and/or emphasis inter-disciplinary, multi-disciplinary and/or trans-disciplinary approaches in the activities undertaken by the Institute.
- 4.24 To co-operate, collaborate, otherwise get involved or engaged in establishment or regional centres of the Institute, with the Government whether Centre, State or local, universities, associations, societies, institutions, organisations etc.
- 4.25 To contact, commence, establish, maintain, relationships/arrangements with researches, studies and other activities carried on in India and/or abroad in the areas related to or connected with the objects of the society as also with the persons, writers, researchers, experts, technologists, technocrats, in such fields through various modes and methods, including joint and/or cooperative studies and/or projects, meetings, conferences, interchange of visits, seminars, talks and/or otherwise.

- 4.26 To construct, establish, erect build, take on lease, hire, license, or otherwise, acquire, procure, on ownership basis or otherwise, and maintain, administer, and manage halls, hostels and/or all such and other establishments as may be required or deemed necessary from time to time for the boarding, lodging, recreation, welfare, and/or other related activities/purposes of/for the pupils, staff, and/or other persons connected with the Institute/Society.
- 4.27 To take, accept, acquire, by way of gift, purchase, exchange, lease, license, hire or otherwise, howsoever, whether on ownership basis or otherwise and/all movable and/or immovable property whether tangible or intangible and hold, use, utilise, dispose off, deal with, engage the same in appropriate ways, means and manners for the purpose of the activities of the Institute/Society.
- 4.28 To build, construct, establish, erect, take on lease, rent, hire, license or otherwise acquire, whether on ownership basis or otherwise and hold, use, maintain, administer, manage, run, rebuild, reconstruct, re-establish any/all kinds of establishments, buildings, structures, laboratories, plants, workshops, factories, equipment, materials, parts, vehicles, pilots plants, research establishments and any/all kinds of property, which may be required or deemed necessary for the purposes of the activities of the Institute/Society.
- 4.29 To deal with, dispose off or otherwise alienate any property or part thereof or any right pertaining thereto, belonging to or vested in the Society, as may be required or as may be deemed fit for the purposes of the activities of the Society/Institute.
- 4.30 To build, erect, construct, establish and/or otherwise, acquire on ownership basis or otherwise, reconstruct, re-erect and re-establish and maintain, administer, and/or manage, contract out the management and/or maintenance of, such residential, recreational, welfare, civic and/or any/all such other facilities, establishments, buildings, provisions, gardens, roadways, etc. for the officers, Directors, Governors, employees, staff and/or other person(s) connected with the activities, of the Institute/Society as may be required or deemed fit.
- 4.31 To erect, construct, establish and/or acquire on lease, rent, license, exchange, settlement, or on ownership basis, or otherwise, reconstruct, re-establish and/or maintain, manage and/or contract out the maintenance and/or management of, such guest houses, out-

houses and/or such other establishments as may be deemed appropriate and/or necessary for the visiting faculty, dignitaries and/or such other persons.

- 4.32 To invite, tender, negotiate, enter, into agreements, arrangements, contracts with contractors, sub-contractor and/or other persons, firms or bodies corporate for the purposes, inter alia, of building, constructing, treating, acquiring, leasing, hiring, licensing, furnishing, managing, maintaining, running and/or any/all other activities connected therewith or relating thereto in respect of any/all property, whether movable or immovable, acquired, to be acquired, proposed to be acquired and/or dealing with disposing and/or alienating the same, at any time, by/of the Society/Institute.
- 4.33 To designate, establish and/or create, continue and/or discontinue any/all administrative, technical, managerial, ministerial and/or other posts, positions, honours, jobs, works assignments, engagements, etc. whether ad hoc, temporary, permanent, and/or otherwise under the Society/Institute and/to make the appointments, suspensions, dismissals, etc. thereto, in accordance with the rules and regulations and/or bye/laws of the/Society.
- 4.34 To create, appoint form, constitute, suspend, discontinue, dismiss, such committee or committees as may be required or deemed fit for the purposes of any/all activities of the Institute/Society and/or for any other matter pertaining to or connected therewith.
- 4.35 To contact, negotiate and establish connections and arrangements with various agencies/institutions/ industries/governments and organise/coordinate with them in respect of matters/activities connected with the placement of pupils and/or other persons awarded/granted degrees, diplomas, etc. of/by the Institute.
- 4.36 To take out, apply for, procure, acquire, establish, register any/all licenses, patents, patent rights, copyrights, permissions, grants, marks and such other things in respect of research, inventions etc. whether innovative and/or original, and/or other work and activities of the Institute/Society.
- 4.37 To take out, procure, acquire, apply for any/all kinds and types of licenses, permits, permissions, approvals etc. as may be necessary and/or desired for the purposes of carrying on the activities of the Institute/Society.

- 4.38 To contact. Negotiate, co-ordinate, collaborate, with the industry, various agencies, organisations, institutes, clubs, whether governmental or otherwise, in India and/or abroad, involved in formulation of standards in respect of products, plants, machinery, specifications, design, parts, relating to steel, steel industry including secondary steel industry and/or evolve its own standards in respect thereof and/or get, procure, acquire, establish, recognition thereof by and/or from industry, government, and/or other organisation/institutes.
- 4.39 To write, print, publish, post, distribute, sell, and/or cause to be written, printed, published, distributed, sold any/all books, journals, news/letters, digests, reports, magazines and/or any other written/printed material in respect of or connected with the activities/objects/of the Institute/Society, in India and/or abroad.
- 4.40 To buy, purchase, procure, take, accept whether for consideration or otherwise, from any source whatsoever, any/all books, journals, periodicals, digests, reports, magazines, documents, papers, and/or any/all other published/printed/written material in any/all forms and content like paper, films, audio and video tapes, cards, floppies, chips, computerised materials etc. in India, abroad, by/from Government, private institutions or otherwise, whether directly or indirectly connected with activities/objects, of the Institute/Society.
- 4.41 To promote, encourage, its pupils, staff etc. to participate in or get involved with the activities of National Cadet Corps and/or similar institutions/organisations.
- 4.42 To set up build, provide, arrange, organise, manage and/or maintain various facilities, and amenities, and/or cause the same to be done, for the purposes of encouragement and promotion of sports, gymnastics, social, cultural and such other activities for the pupil and staff etc. of the Institute/Society, and to arrange, organise, encourage their participation in competitions, games, activities in sports, gymnastics, recreational, social and cultural activities at both local, state, national and international level.
- 4.43 To endeavour to provide, arrange, organise, primary health services and/or basic and other medical facilities for the pupil and/or staff of the Institute/Society.

- 4.44 To endeavour to provide, arrange, organise, primary school facilities for the children of staff, employees etc. of the Institute/Society.
- 4.45 To adopt communities, groups, and/or institution/organisation, people, for their upliftment in educational and/or cultural fields.
- 4.46 To seek, procure, acquire and take all other necessary steps relating thereto for the purposes of recognition of the Institute by the appropriate authorities and thereby resulting in grant of status of a University to the Institute or an institute of national importance and/or a recognition of equivalent value/status.
- 4.47 To fix, demarcate, settle, establish, demand, collect, deposit, such fees and other charges as may be required or deemed necessary from time to time from the members, pupils, Governors, institutions, organisations, participants, and other persons, firms or bodies corporate, whether Government or otherwise in India or abroad, availing of facilities/services/benefits of/from the activities of the Institute/Society.
- 4.48 To accept, collect, take, deposit, any/all kinds and types of monies grants, donations, concessions, whether in cash or kind from any/all persons, firm, or bodies corporate whether governmental or otherwise in India and/or abroad.
- 4.49 To open, operate, manage, maintain such bank account(s) in the nationalised bank(s) as may be required or deemed fit and to operate, withdraw, utilise, including over-draw from such accounts, to invest surplus fund as per guidelines issued by Deptt. of Public Enterprises, Ministry of Industry, Govt. of India.
- 4.50 To spend, utilise, expend, provide any/all monies lying in the bank or otherwise for the purposes of the objects/activities of the Institute/Society as also any/all other activities, actions, deeds, works, jobs, connected therewith, including payments of remuneration, pensions, allowances, contracted amounts to all such persons, firms or bodies corporate as are engaged in any/or connected with the activities of the Society/Institute.
- 4.51 To invest, give loans etc., and deal with the monies of the Society which are not immediately required by the Society/ Institute for its activities as per the modes approved by DSIR/Income Tax Act.

- 4.52 To borrow, raise, procure, acquire with or without security monies from any source whatsoever and/or to create the necessary charges/securities by way of mortgage, hypothecation, pledge, etc. on/or in respect of any/all movable and/or immovable properties belonging to or vested in the Society or in any other manner whatsoever.
- 4.53 To make, give, declare, provide donations, grants, subscriptions, and/or otherwise assist any person, firm, bodies corporate, institutions, bodies, clubs, which may be required or as may be deemed fit.
- 4.54 To develop, construct, erect, maintain, manage, lands, buildings, roads, drains, water works, structures, workshops, laboratories, playgrounds, stadia, recreation centres, clubs, civic centres, auditoria, parks, gardens, printing presses, pilot plants, hostels, halls, houses, out-houses, dining halls, guest houses and such other structures, buildings, as may be required or deemed fit.
- 4.55 To establish, maintain, continue, and/or discontinue one or more provident fund and/or superannuation fund and/or such funds as may be deemed fit or necessary for the benefit of the pupils/staff/employees of the Institute/Society in accordance with the applicable laws.
- 4.56 To do any/all the above things in any part of the world including India as Principals, Agents, Contractors, Trustees or otherwise and either alone or in collaboration joint venture with any other person, firm or body corporate.
- 4.57 To prepare, sign, file, apply, execute, register, any/all kinds of papers, correspondence, documents, memoranda of understanding, agreements, returns, applications, contracts, deeds, notices, etc. for, in connection with or in relations to any/all the aforesaid activities/objects.
- 4.58 To produce gas and/or electricity of the purposes of the activities of the Society/Institute and to process all products resulting from or ancillary to such production and making of gas, to convert the by-products and to otherwise deal with and dispose of the same and to take all steps incidental or required in respect of the same.

- 4.59 To purchase, take on lease or in exchange or under amalgamation, license or concession or otherwise, absolutely or conditionally, solely or jointly with others and make, construct, maintain, hire, hold, improve, alter, manage, let, sell, dispose off, exchange, roads, canals, watercourses, water ways and rights ways, leaves, ferries, piers wharves, air-ports, aerodromes, lands, buildings and warehouses, electricity and other works, factories, mills, workshops, railways, sidings, tramways, ropeways, drainage and sewage works, engines, machinery, equipment and buildings, plants and works of every description and kind which may be calculated directly or indirectly to advance the interests of the Institute/Society of conducive to the interests of the Institute/Society of conducive to the attainment of the objects of the Institute/Society.
- 4.60 To apply for, purchase or otherwise acquire and protect, prolong and renew in any part of the world any patents, patent rights, brevets d' invention, trade marks, designs, licenses, protection, concessions, and the like conferring an exclusive or non-exclusive or limited right to their use or any secret or other information as to any invention, process or privilege which may seem capable of being used for any of the purposes of the Society/Institute or acquisition of which may seem calculated directly or indirectly to further the objects of the Institute/Society and to use, exercise, develop or grant licenses or privileges in respect of or otherwise turn to account the property, rights and information so acquired.
- 4.61 To enter into any arrangement with any Government, Central, State local or foreign, or authority, supreme, municipal, local or otherwise or body corporate, firm or person, that may seem conducive to the objects of the Institute/Society or any of them, and to obtain from any such Government, authority, body corporate, firm or person, any concessions, grants decrees, rights subsidies, loans, indemnities, sanctions, protection, charters, contracts, licenses, powers and privileges, whatsoever, which the Institute/Society may think it desirable to obtain and to carry out, exercise and comply with the same.
- 4.62 To negotiate loans for the Company or other persons or bodies, to lend monies, securities and other properties, to draw, make, accept issue, endorse, discount, buy sell and deal in bills of exchange, promissory notes, hundis, drafts, bills of lading, warrants and other negotiable or transferable instruments, and all kinds of securities to become sureties and guarantors for any such purposes.

- 4.63 To insure any of the properties, undertakings, contracts, guarantees or obligations of the Institute/Society of every nature and kind in any manner whatsoever.
- 4.64 To obtain any order or Act of Legislature or Parliament for enabling the Society/Institute to obtain all powers and authorities necessary or expedient to carry out or extend any of the subjects of the Society/Institute or for any other purpose which may seem expedient and to oppose any proceedings or applications which seem calculated directly or indirectly to prejudice the interest of the Society/Institute.
- 4.65 To aid and support, pecuniarily or otherwise, any person, association, body or movement, having for an object the solution, settlement or surmounting of industrial or labour problems or troubles or the promotion of industry concerning the objects of the Society/Institute or related interests.
- 4.66 To adopt such means of making known the objects/activities of the Society/Institute as may seem expedient, and in particular by advertising through any audio-visual means, in the press, by circulars, by purchase and exhibition of works of art or interest, by publication of articles, pamphlets, newsletters, books and periodicals, and by granting prizes, rewards and donations or in any other manner considered suitable.
- 4.67 To guarantee the payment of money unsecured or secured by or payable under or in respect of promissory notes, bonds, debentures, debenture-stock, contracts, mortgages, charges, obligations, Instruments and securities of any company or of any persons whomsoever whether incorporated or not incorporated, and generally to guarantee or become sureties for the performance of any contracts.
- 4.68 To promote, establish, maintain manage, administer, run etc. any other institute referred to in clause 4.1 above and to do all acts, things and deeds referred to above, in connection with and/or relating to such institute.
- 4.69 To make alter, amend, change modify, from time to time the rules and regulations and bye-laws of the Society/Institute.
- 4.70 To do any/all acts, things and deeds as may be necessary incidental or conducive to the attainment of any/all the aforesaid objects as also

in respect of any/all other matters, deeds and thing connected therewith.

- 5.1 The Institute shall be open to persons of both sexes and of all race, domicile, creed, caste or class and no test or condition shall be imposed as to religious belief or religious profession in admitting or appointing members, students, teachers, workers or any other person in connection with the purpose and activities of the Society.
- 5.2 No bequest, donation or transfer of any property shall be accepted by the Institute which in the opinion of the Board involves conditions or obligations opposed to the spirit and object of the above sub-section.
- 6.0 All teaching, training research and related activities shall be conducted by or in the name of the Institute in accordance with the rules, regulations, and bye-laws made in this behalf and as amended from time to time by the Board.
- 7.0 The Board may at any time appoint one or more persons to review the work and progress of, or for such other purposes, as the Board may decide, in relation to or connected with the Society or the Institute and to hold an enquiry into the affairs thereof and to report thereon, in such manner as the Board may stipulate. Upon receipt of any such report the Board may take such action and issue such direction as it may consider necessary in respect of any of the matter dealt with in the report regarding the Society or the Institute, as the case may be, and the Society shall be bound to comply with such directions. The Board shall have the power to delegate its powers herein mentioned to the Director of the Institute or to any other person(s) as it may from time to time decide.
- 8.0 The income and property of the society shall be applied solely towards the promotion of the objects of the Society as set forth in the memorandum of Association, and no portion thereof shall be paid or transferred, directly or indirectly, to the members of the Society.
- 9.0 The Society, by its Constitution is required to apply its surplus/excess of income over expenditure, if any, or other income in promoting its objects.
- 10.0 If upon the winding up or dissolution of the Society there remains after satisfaction of all its debts and liabilities, any property whatsoever, the same shall not be paid to or distributed among the members of the

Society, but shall be given or transferred to some other institution having objects similar to the objects of the Society to be determined by the members of the Society at or before the time of dissolution.

11.0 The Board shall be empowered to induct new members, expel/suspend members, accept resignations from members in the manner provided in the rules and Regulations of the Society.

12.0 The names, addresses, occupations and designations of the first members of the Board of Governors of the Society to whom, by the rules of the Society, the management of its affairs is entrusted are:
